PUPPY SALE CONTRACT

SELLER AGREES:

- Above puppy has been found to be in good health.
- Above puppy has received all necessary vaccines and dewormers.
- Above puppy has been examined by a veterinarian and buyer has been informed of any concerns.

At the time of sale, this puppy is considered as and is being sold as a quality pet. Bonham Puppies offers no guarantee that disqualifying faults will not arise at a later date which would make this puppy unsuitable for the show ring or for breeding.

BUYER AGREES:

- To pay the remaining amount due at pickup.
- To have above puppy examined by a veterinarian within 72 hours of pickup (excluding weekends) and to provide documentation to the seller verifying the results of the exam.
- That all veterinary bills are the responsibility of the buyer.
- That this puppy is not to be used for breeding under any circumstances (any breeding, even if accidental, voids all guarantees).
- To notify Bonham Puppies within one year if the buyer can no longer care for the puppy (under these circumstances, the puppy must be returned to Bonham Puppies at no cost to Bonham Puppies).
- That this puppy cannot be transferred to a third party without written consent from Bonham Puppies. This contract applies to the original buyer only and is non-transferable to a second party.
- To inform Bonham Puppies of any health issues regarding the puppy so that Bonham Puppies can work to eliminate these issues from the breed. The buyer also agrees to forward veterinarian statements to Bonham Puppies explaining these health issues.
- That if the puppy should pass away for any reason, an autopsy must be performed at the buyer's expense and that results must be forwarded to seller within 15 days.



72-Hour Health Guarantee

This puppy is guaranteed to be in good health at the time of delivery. The buyer agrees to have the puppy examined by a licensed veterinarian within 72 hours of pickup (excluding weekends and holidays). If the puppy is found to be in unacceptable health, a written statement from the veterinarian must be forwarded to the seller, and the puppy must be returned within 72 hours (at buyer’s expense) for a replacement. If no replacement is available, a full refund will be given.

This gurantee is limited to health issues arising from dieases or parasites, and does not apply to illnesses arising from neglect or improper care of the puppy by its owner.

1-Year Replacement Guarantee

If the above puppy should develop a severe genetic disease before it’s first birthday and can no longer function as a pet or companion animal, Bonham Puppies will replace the puppy at no charge with a comparable puppy. The puppy will be replaced with another puppy from the same litter or from a future litter. If no replacement is available, then a full refund will be given.

Proper documentation from two licensed veterinarians stating the problems found and explaining each veterinarian’s opinion regarding the viability of the animal must be sent to the seller within 15 days of diagnosis. The seller will have the final say whether or not the puppy must be returned. All the veterinary bills and/or return shipping expenses are the responsibility of the buyer and will not be reimbursed by Bonham Puppies.

This guarantee does not apply to uneven bites, un-dropped testicles, or umbilical hernias.

Unless otherwise specified, all veterinarian bills for corrective surgery, cosmetic surgery, shots, euthanasia, spaying/neutering, normal health care, and also shipping costs are the responsibility of the buyer.

Buyer gives permission for Bonham Puppies to contact buyer’s veterinarian to discuss any health issues that may arise in this puppy to aid in improving the health of future litters from Bonham Puppies _____ (buyer initial here).
